#### **Closing Date for pre-entry is the day prior to the trial**

Earn an agility title on your beginner dog in a trial atmosphere! The Agility Course Test is an entry level agility event to introduce beginning dogs and/or handlers to the sport of agility. Dogs must be 15 months old to enter and must meet the requirements for a regular agility trial (Chapter 1, Section 3), except that they need not be AKC registered to enter.

**ACT Level 1** is open to all dogs who have not earned any AKC titles. The course will have 10-12 obstacles including a 5' AFrame, table, tunnel, bar jumps (no spreads). Tire and panel jump are allowed but not required. Time for the course will be 60 seconds and a score of 85 is required.

**ACT Level 2** is open to all dogs who have not earned any AKC titles except for an ACT1 title. The course will have 11-13 obstacles. All Level 1 obstacles will be used with the addition of a teeter, tire, 1 spread and 6 weaves. Time for the course will be 70 seconds and a score of 85 is required.

**ACT Level 1 Jumpers** is open to all dogs who have not earned any AKC titles. The course will have 10-12 obstacles consisting of bar jumps and tunnels. Tire and panel jump are allowed but not required. Time for course will be 50 seconds and a score of 85 is required to qualify.

**ACT Level 2 Jumpers** is open to all dogs who have not earned and AKC titles except for a ACT1J title. The course will have 11-13 obstacles. All level 1 obstacles will be used with the addition of required 6 weaves and one spread jump. Time for course will be 60 seconds and a score of 85 is required to qualify.

**Refusals and Run outs** are not judged. More than 3 attempts will result in an elimination/failure to perform. Table faults, Wrong courses and Failures to Perform will be judges as in a regular agility class. Two passing scores are needed for a title and can be under the same judge.

**Jump Heights** are at the handler's discretion. Jump Heights are 4,8,12,16,20 inches. A jump height card and measuring are not required.

**Entry fee:** Pre-entry is \$15 per run (including \$5 AKC recording fee) Day of show is \$20 per run (including \$5 AKC recording fee)

Day of show entries will be taken if limit has not been reached between 11:00 am and 11:30 am.

**Entry Limit** is 75 total for the day. Closing date for pre entry is 1/15/21. Entries not received by 1/15/21 will be considered DOS.

**Check in** 11:15-11:30 am. Briefing will be at 11:45 am followed by a 5-minute walk thru. Judging will start at 12 pm. Tall to small in each class. Tests will run inside on turf. Plenty of indoor crating. Heated and/or AC. Rubber contacts.

**Judging Schedule** ACT 1 (Rd 1), ACT 1 (Rd 2), ACT 2 (Rd 1), ACT 2 (Rd 2)

*If your dog has done well in the ACT1 and you would like to try the ACT2, we will add your ACT2 entry if limit has not been reached. Confirmation will be emailed prior to the trial.*

**Awards** – All Qualifiers will receive a Flat Green Qualifying score ribbon per qualifying score. Any ACT1, ACT2 Titles earned will receive a title rosette.

**Dogs that are not registered with AKC** are eligible to participate and their performance will be recorded by AKC under a temporary recording number. This will be emailed to you and must be used when entering any subsequent ACT events. You cannot use that for any other AKC events except for the ACT events

**Entries will be accepted as received.** Your entry must be complete and signed or will not be accepted. No phone, email or fax entries will be accepted. Returned checks will not constitute a valid entry and a \$30 charge will be collected in addition to the entry fee. There will be no refunds if your dog is absent, excused or barred from competition. Refunds will be given for bitches in season upon inspection or a letter from a veterinarian.

**Directions to Show Site** 15 Lancaster Pkwy, Lancaster, NY 14086

From I-90 Transit Road exit-Left at Genesee Street Signal-Left onto Pavement Rd.- When arriving at Lancaster Parkway please follow driveway to back and look for big red building

No dogs are allowed off leash except when in the ring and only enter the ring when the dog before you is out of the ring and gate is closed. Ring size is 93 X 100 feet. Turf footing.

**INSTRUCTIONS**

Dogs may be entered in any jump height. There is no Regular or Preferred distinction at AKC's ACT events.

In order to acquire the ACT1 or ACT2 title certificate and have the title added to a dog's record, the dog must be registered/listed with the American Kennel Club. **AKC Canine Partners**™ applications may be accepted at the event and submitted to AKC with the event's results.

Dogs that are not AKC registered/listed may be registered at a later date and receive their ACT title at that time.

Dogs listed in the **AKC Canine Partners**™ program should be listed as All American Dog and must include their AKC number on the entry form and check the AKC No. box

**Junior Handlers** should enter their Junior Handler Number on the front of this form. Should you not have your Junior Handler number, it may be obtained from the American Kennel Club (919) 233-9767. If the Junior Handler is not the owner of the dog identified on the face of this form, what is the relationship of the Junior Handler to the Owner?
